ECONOMIC ADVANTAGE**

As of the first day of classes for the term, an economic advantage waiver may be granted to a dependent or independent student who can provide clear evidence that the student or the student's parent, spouse, or U.S. court-appointed guardian has relocated to the State of Georgia to accept full-time, self-sustaining employment and has established domicile in the State of Georgia. Relocation to the state must be for reasons other than enrolling in an institution of higher education. This waiver will expire 12 months from the date the waiver was granted. An affected student must petition for residency status after 12 months and must provide additional documentation according to established procedures at Kennesaw State University. - Copy of parent/guardian/spouse's GA driver's license, or US passport, or US birth certificate, or Permanent Resident card (front & back)

**I understand that I must notify Kennesaw State University immediately if my parent/guardian or spouse is assigned employment outside the State of Georgia. I also understand this waiver, if approved, is valid for 12 months and I must submit a Petition for Georgia Residency once this waiver expires.**
